Dear Clagett Regatta Participants, Coaches and Volunteers,

The Clagett Board of Directors met on August 11, 2021 to discuss the current public health situation, specifically the impact of the COVID-19 Delta variant on the safety of participants at The Clagett Regatta. Our primary concern is for everyone's safety and health.

After receiving the most up to date medical information from the state, the Clagett board has decided that, for the protection and safety of everyone involved in The Clagett, proof of vaccination, in the form of a vaccination card, will be required at the 2021 Clagett Regatta.

Proof of vaccination will only be accepted for those who are "fully vaccinated." The State of Rhode Island currently only recognizes and accepts the definition of those being "fully vaccinated" as defined by the CDC and the WHO. Any hybrid vaccination protocol, accepted outside of the United States and not accepted by the CDC and WHO, will not be recognized as "fully vaccinated" by The Clagett. (Example: One dose of AstraZeneca vaccine and one dose of another vaccine, such as Pfizer or Moderna, is not currently recognized by the CDC and WHO as "fully vaccinated").

The vaccination card is required for anyone in The Clagett space—participants, volunteers, coaches, aides, family and friends of sailors or volunteers—must present proof of vaccination in the form of a physical vaccine card. This will be done at the registration desk. On completion of check in those with a vaccine card will be given a form of identification to be worn at all times. Only those with this identification will be allowed in The Clagett Regatta space.

For everyone's safety do not travel to The Clagett without your valid vaccine card or you will unfortunately not be able to be part of The Clagett this year. Copies or photos of vaccine cards will not be accepted. If you have questions please call the office.

For those competitors who choose not to participate, or are unable to participate, a registration refund will be issued.


The Clagett will encourage the use of masks in the tent, unless eating or drinking. The Clagett is also recommending COVID-19 testing for its safety boat teams, and for those individuals traveling to Rhode Island from out of the state. All participants, volunteers, coaches, and individuals expecting to interact with The Clagett in any way, are expected to follow these guidelines while at The Clagett Regatta, at Fort Adams State Park from August 24-29, 2021.

The Clagett Regatta Board of Directors would like to stress that these requirements are intended to keep all participants and volunteers safe. We all need to be flexible and as guidelines change we will be adhering to the necessary guidelines to keep everyone safe.
